Gift Aid Scheme

Increase your Donations at NO COST to yourself

Gift Aid is a scheme by which, provided you pay tax, you can give a sum of money to charity and the charity can reclaim from the Inland Revenue basic rate tax on your gift.

This is of considerable importance to the Trust. Since April 6th 2000 any money given to the Trust, either as Membership Fees or Donations may be treated under this Gift Aid Scheme and the Trust can reclaim 26p for every £1 it has received. All you have to do – provided you pay tax – is complete the form below: it is very simple – there are no requirements for tax references, annual form filling or long-term commitments.

Remember:

- You must pay an amount of income and / or capital gains tax at least equal to the tax the Trust will be reclaiming on the money you give to the Trust.
- You can cancel this arrangement at any time by notifying the Trust e.g. if you no longer pay tax.
- If you pay tax at the higher rate you can claim further tax relief in your Self-Assessment tax return.
